Ahmed Maher Teaching Hospital is a central teaching hospital in Cairo; drains large number of casualties from surrounding motor ways, industrial estates, and city centre, using contemporary fracture treatment techniques. A great deal of the elective hip and spinal surgery comes as secondary referrals. As a registrar I was responsible for the primary resuscitation and management of orthopaedic injuries together with performance of elective surgery.

Completed a Master's Degree in Orthopaedics with a thesis on Total Elbow Replacement.

This was a review of the anatomy and biomechanics of the elbow and elbow implants. I reviewed the history of Elbow implants and the different generations. I included all the models that were available at the time of writing including radial head implants, metal, silastic prostheses and implants for the upper end of ulna and lower end of the humerus. I reviewed the materials used in implant manufacture and the behaviour of cemented, cementless and silastic elbow implants and allografts. Included was a literature review, and a detailed description of the different techniques of inserting each model and a detailed description of all the complications and their management. I included two local series of about 25 cases each where I reviewed the patients personally and was involved in operating on most of them. I compared the results of these cases against the other published literature series and drew my conclusions.

In addition, I was on call for trauma on a 1:4 rota with my consultant colleagues. Although I was given six months to meet the workload, the whole lot was cleared in four months time. I used to see my old and new patients. As the waiting list problem was solved well ahead of time, I applied to move to Newham General Hospital.

Since my arrival to Newham General Hospital, I have inherited all the back (spinal surgery) referrals. At the time of my arrival the out patient waiting list for back new patients was running at 24 per week. As this backlog has cleared, I see 16 new backs per week and have dropped the waiting time for new back referrals to three weeks. I was on call for all back emergencies on a daily basis and provided referral back service for my consultant colleagues at Newham General Hospital. I have managed to cut down my waiting list time from 18 to less than 6 months, which is very low figure for that region. I have introduced the use of chymonucleolysis to the district. This has been so successful in cutting down the operation time, cost of stay in the hospital. It has also attracted extracontractual referrals. The results of this have been audited. I intended to extend my expertise to treating back fractures by fixation, a service currently available only in Stanmore Hospital. I gained a special experience at Newham District dealing with tropical and subtropical diseases not commonly seen in UK such as Poliomyelitis, TB and Sickle cell Disease. This is due to the high percentage of immigrants in the district. It is unfortunate that I had to leave this hospital due to the fixed term contract.

This is a busy District General Hospital with very active postgraduate teaching programs. There is a distinct speciality interests in the department. We receive referrals from near by hospitals to our special interest firms which include upper limb, spine, arthroscopy, joint replacement, revision and paediatric surgery. The trauma service is very comprehensive and includes polytrauma and complex spinal cases. During my stay in this hospital, I managed to cut down the waiting list time from above twenty months to less than eight months. My previous experience as a substantive consultant was put to use and I was also involved in the teaching and managerial issues of the department.

On my Arrival to this hospital, I was not given any fund to develop any special interest. I found that the practice of all aspects of Trauma & orthopaedics is at least 30 years out of date. Only one of my predecessors used to take his joint replacements to another central hospital. AO system and intramedullary nailing were unheard of. Currently, this ,including some revisions, is taking place like any DGH.

ACL reconstruction, different joint Arthroscopies and spinal surgery were also unheard of. These now currently appear on everyday orthopaedic lists.

For both trauma and elective surgeries, business cases have been presented to the trust board to stop referring straightforward cases to other centres. There appears to be little

improvement in this respect. Instruments for most everyday procedures still has to be hired with expensive prices and booked in advance rather than being on shelves.

I have also succeeded in enrolling some of the clinic nurses in plastering courses to improve the totally unacceptable quality of plasters that I have come across on my arrival earlier in the trust.

I have also produced set protocols for care and postoperative management of variety of cases. These are now in place and adhered to by the wards and physiotherapists that were not used to this standard of orthopaedics.

I have a special approach to tackling my waiting list. It has been successful and cut down my waiting time.

The quality of Orthopaedic service in the valleys has improved.

I have also managed to restore recognition of the Royal College of surgeons for SHO training. I have introduced the concept of morning trauma meeting and ward round. I am currently working on SPR recognition. I have introduced regular teaching and audit programme, Workshops, and journal clubs in the department. There are some research projects going on which will be submitted for publication.

I have demonstrated to the trust by audit & business case the importance of having trauma list arrangement as required for training by the Royal colleges.

However, as a team leader, I am continued with my duties as best as can be within very tight resources.

I have stretched the capabilities of this place to its limits. I needed a place that appreciates hard work.

Experience & special Interest:

During my comprehensive training I was exposed to all areas the major sub-specialities of orthopaedic surgery.

I have taken different speciality interest during my different posts. That has involved enrolling in special refresher and master class courses. Being in the beginning of my career, and with basic orthopaedic training, I am prepared to take different interest. ***I have set up newly introduced services in my present and previous jobs. I am prepared to develop a speciality interest to match the needs of the job.***

Spinal Surgery: I acquired a good deal of my Spinal surgery experience at an early stage in my career when I worked for a spinal surgeon in Cairo, who supervised a paper I presented about spinal Stenosis. I acquired the bulk of my surgical experience as a Senior Registrar to Mr. D. Wardlaw and Professor Porter who are the back surgeons for the whole of North East Scotland, the Highlands and the North Sea Islands. The other part of experience in spine surgery I gained from working as a senior registrar to Mr. D. Markham in Manchester Royal Infirmary and as a registrar to Mr. Scott Furgesson at Northampton General Hospital. I have also worked with different spinal surgeons during my career including an SHO post with Mr. J. Taylor who does scoliosis, but I don't think I will be able to provide this kind of service in a District General Hospital. I receive spinal cases internal referrals from my colleagues. I enlarged on this experience during my substantive jobs

Hand and Upper limb surgery: Since I started my orthopaedic career in Cairo, I was exposed to the acute management of hand injuries from surrounding glass factories and workshops. My MSc. thesis is related to upper limb surgery. Most of my jobs in the UK involved working with hand surgeons, some of them are authorities in their field. I was acting as SR to Mr. N. Fahmy the inventor of S-Quattro Fixator, Mr. M. Morris, and Mr. J Dias. I have also worked with Mr. R.B. Chesney and many others. All have their own way of managing hand problems. I have learned different methods of management of hand problems, which helped me to choose my own. I receive Hand Surgery cases as internal referrals from my colleagues.

Paediatric Orthopaedics: In Cairo I have been exposed to polio surgery. Whereas in Alder Hey I was exposed to cerebral palsy. That was in somehow complementary. Needless to say that this is a tertiary referral centre dealing with a huge variety of paediatric orthopaedic problems. While in Falkirk, Inverness, Aberdeen and other places I rotated to firms with paediatric interest. My job in South Tyneside hospital had a special interest in Paediatric and Arthroscopic surgery.

Joint Replacement/ Revision and Rheumatoid Surgery: Revision and primary replacement are closely interrelated. I have worked for surgeons who have interest in elbow and shoulder surgery. This is also interrelated to upper limb and rheumatoid surgery. I have been involved through these in combined clinics between rheumatologist and orthopaedic surgeons. I am comfortable with primary and revision joint replacement procedures.

Trauma, Sports, Arthroscopic Microscopic surgery: I am confident to deal with all types of fractures including Calcaneum, talus, complex shaft and Pilon Fractures and simple pelvic fractures, using (wherever appropriate) plates, external fixators, and intramedullary nails. I'm very happy to deal with different types of hand injuries including the repair of tendons, nerves and blood vessels using (if available) the operating microscope or magnifying loops. I'm also happy carrying out arthroscopic Shoulder, knee, and ankle procedures, as well as cruciate ligament reconstruction & Meniscal Suturing.

My current weekly time table has a fixed slot for Medical Students Class. Medical Students are also allocated to my clinic, theatre and ward round sessions.

During all my hospital appointments I was deeply committed to teaching medical students attached to the hospital. In major teaching hospitals, student classes were part of my regular timetable, for at least one session a week. My team would usually consist of an SHO and a Registrar. I always consider teaching the students, housemen, registrars and nursing staff a mutually beneficial experience to which I always allocated a good deal of time. I enjoy teaching my juniors and taking them through procedures. I always have / welcome elective and Clinical Attachment students attached to my unit. We run an intensive training program for students and juniors. This includes presentations, lectures and journal clubs.

I always contribute to and arrange the department and hospital audits and lunchtime presentations of cases and papers, journal clubs and workshops. I draw the academic program for the department.

I am still committed to continuous medical education. Despite being in a permanent post. I managed to obtain a higher postgraduate degree and few publications. I am also booked to join courses and conferences. There is also a good number of papers submitted or in the process of being submitted for publication. I am still regular and encouraging the attendance of regional teaching programmes.

Administrative/ Audit/ Leadership Experience

As a locum then substantive consultant, I was exposed to hospital politics and the trust environment. I gained a good deal of experience not available to senior registrars in dealing with the managers and GP (at the time-fund holders). For instance, while in Bishop Auckland, I had to liase with 13 GP fund-holding practices. In Newham, I have to liase with 40 single-handed GP Fund holders as well as a "Multifund" Union of fund holders. I also have the edge in other management issues, which do not attract a good deal of attention in the training of juniors, such as, divisional meetings, senior staff, risk management groups, audit and other committees, and administrative issues. For waiting lists handling I handle my own waiting list. This is the reason why I end up having the shortest waiting list wherever I go. I have liased with our computer and audit department and produced a computer generated multipurpose program, which can generate discharge summaries as well as audit and statistical data.

I am in charge of audit program in our department. I am also the lead clinician in the surgical division for NICE Project.
