Medical Reports

Cost of reports:

Liability and Causation	£1250 – £2750 depending on the extent of medical records and complexity of the case.
Time for preparation:	Four to eight weeks from the date of receipt of the clinical records and letter of instruction, unless otherwise arranged.
Submission of records:	Please send all correspondence to: 24 – 28 The Broadway, Amersham HP7 0HP Please note that electronic submission of clinical records, documents and correspondence is preferred. Please submit all documents via email, file transfer or on disk where feasible. Medical records supplied on paper cannot be returned.
Condition and Prognosis	£1350 - 1950 to include clinical and duplex ultrasound examination
Appointments for examination:	Available within 4 weeks of receipt of letter of instruction. The report will be available 1-2 weeks following the examination.
Supplementary fees:	This fee does not include fees for preparing supplementary reports or advice concerning the original report.
