For solicitors, while the tasks have been broadly similar, the results have been used to assist in the preparation of defence cases. Most of this work has concerned GPS and GNSS satellite navigation equipment, tracking systems for motor vehicles, GPS and mobile phone jamming, or covert surveillance equipment.
