## Relevant projects

Expert Witness for Arbitration Case Between Customer and Manufacturer, 2015-2016

Acted as HACCP and microbiology expert witness for dispute between UK customer and a contract manufacturer in US. This case involved a review of the efficacy of the customer's process protocol and the contract manufacturer's delivery of product to that process. The case went to trial in the US.

## Expert Witness for Bristol Council vs Hotel Chain, 2015

Acted as microbiologist expert witness for the defence (hotel chain). This was a food poisoning case involving survival of Campylobacter in chicken liver pate for a wedding party meal. At least 33 people contracted food poisoning.

Expert Witness for Havering Council vs The Railway Hotel Hornchurch, Essex - 2014

Acted as microbiologist expert witness for the prosecution. This was a food poisoning case involving the survival and growth of *Clostridium perfringens* in a Christmas roast dinner, where one person died and 30 had food poisoning. The case was successful, and all three defendants were prosecuted.

## Process Review for Major International Airline 2011/2012

In 2011/2012 Peter was part of the multidisciplinary project team that undertook a systematic review of the catering process from kitchen to consumer for a major international airline. This project was successful in identifying issues within their processes that were contributing unnecessarily to product failure and rejection.

## Expert Witness for a Legal Case 2011-2012

This was a microbiological problem that occurred between an ingredient supplier and a manufacturer. Peter was the key Leatherhead contact. His inputs helped to drive down the claim for damages to his client from £2,000,000 down to £250,000.

#### Development of Auditing Guides for a Certification Body 2012

Peter was part of a multidisciplinary team that used the British Retail Consortium (BRC) Global Food Standard for Food Safety as a basis for providing information for guides for interviewers of potential auditors, and for auditor skills training. Guides were produced across all 18 sectors of the BRC Standard
