Perazzoli & Ors v BankSA & Anor

Michael Samra is a name that may ring a few bells in the legal fraternity. Between 2007 and 2009, Mr Samra operated a Ponzi Scheme in South Australia through the Adelaide Lending Centre (ALC) Group that saw investors lose significant funds. The ensuing 2014 Federal Court case – Perazzoli & Ors v BankSA & Anor – ended when BankSA agreed to pay a landmark \$13.25 million out-of-court settlement.

The settlement is one of very few in Australia in which investors stung in a Ponzi scheme have taken successful action against the scam operator's bank.

During the case, Bruce Debenham, Director of Banking and Finance at Perks, was engaged by the solicitors acting for the lead applicants in the class action against the bank to provide an independent expert report.

With Bruce's breadth of experience and expertise, he was able to provide an independent expert opinion on the standard expected of an honest and reasonable banker in the relevant period in managing client relationships and facilities provided to borrowers engaged in a private lending business, and whether the bank met those standards.

Bruce's expert report played an important role in securing an out-of-court settlement prior to trial in a hard fought case, as it addressed key issues of the bank's alleged liability.

Among other things, Bruce was required to form his opinion on the following matters relating to the case:

- Whether a prudent and diligent banker would have apprehended on reading and considering the ALC Group accounts that they did not record the indicia of a private lending business as represented by Samra;
- The enquiries that an honest and reasonable banker would have made in light of the facts and circumstances known to the bank during the relevant period, including by reference to any specific the bank internal policy;
- Whether the bank made those enquiries, and if not, whether the bank failure to do so was reckless (as opposed to merely negligent or careless) in light of the facts and circumstances known to the bank and the standard expected of an honest and reasonable banker;

In his judgment approving the settlement, Federal Court Justice Michael Lee described the proceeding "as being akin to trench warfare" in reference to the manner in which the bank had defended the proceeding to date.
